PROPOSAL INFORMATION

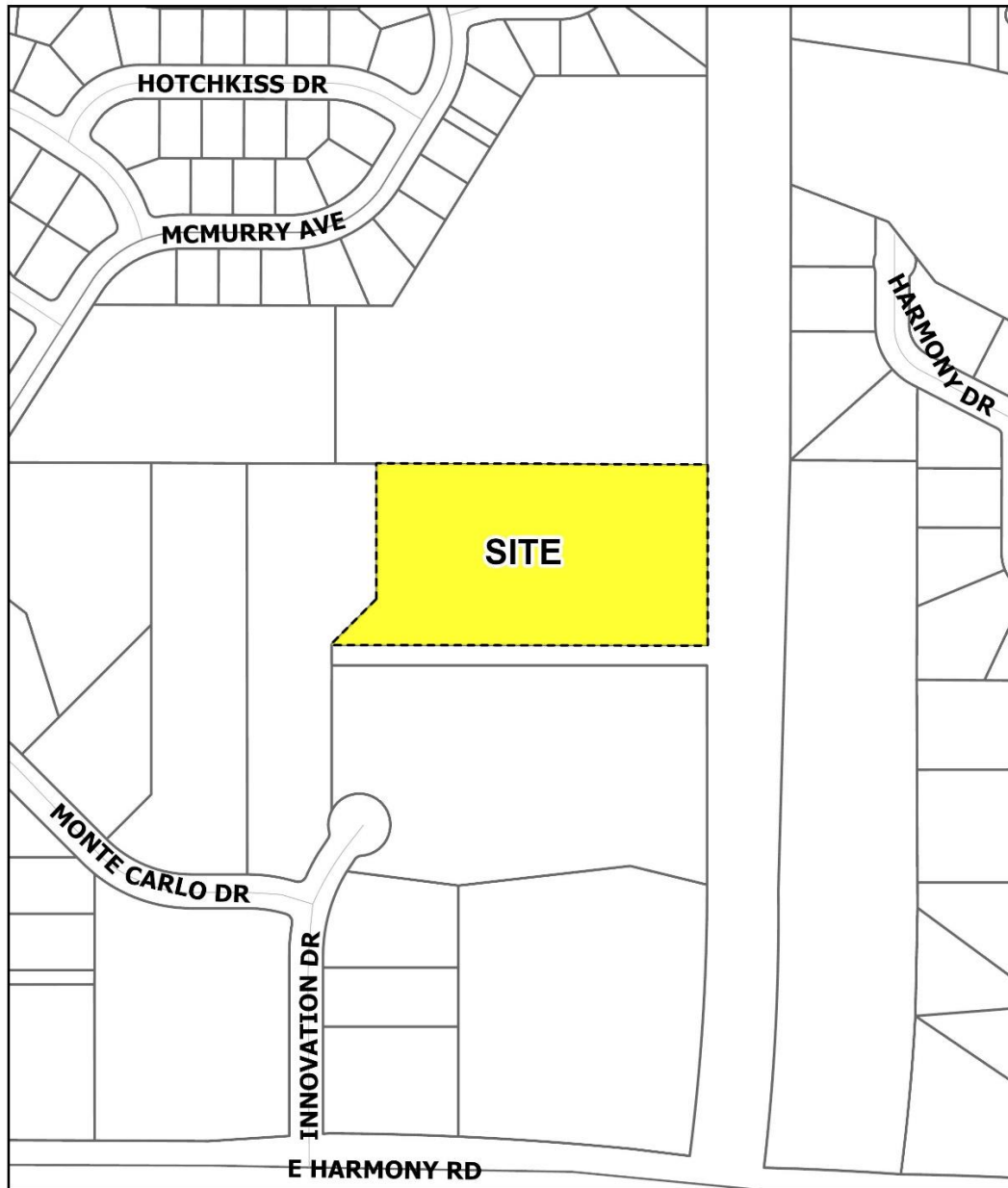
