PROPOSAL INFORMATION

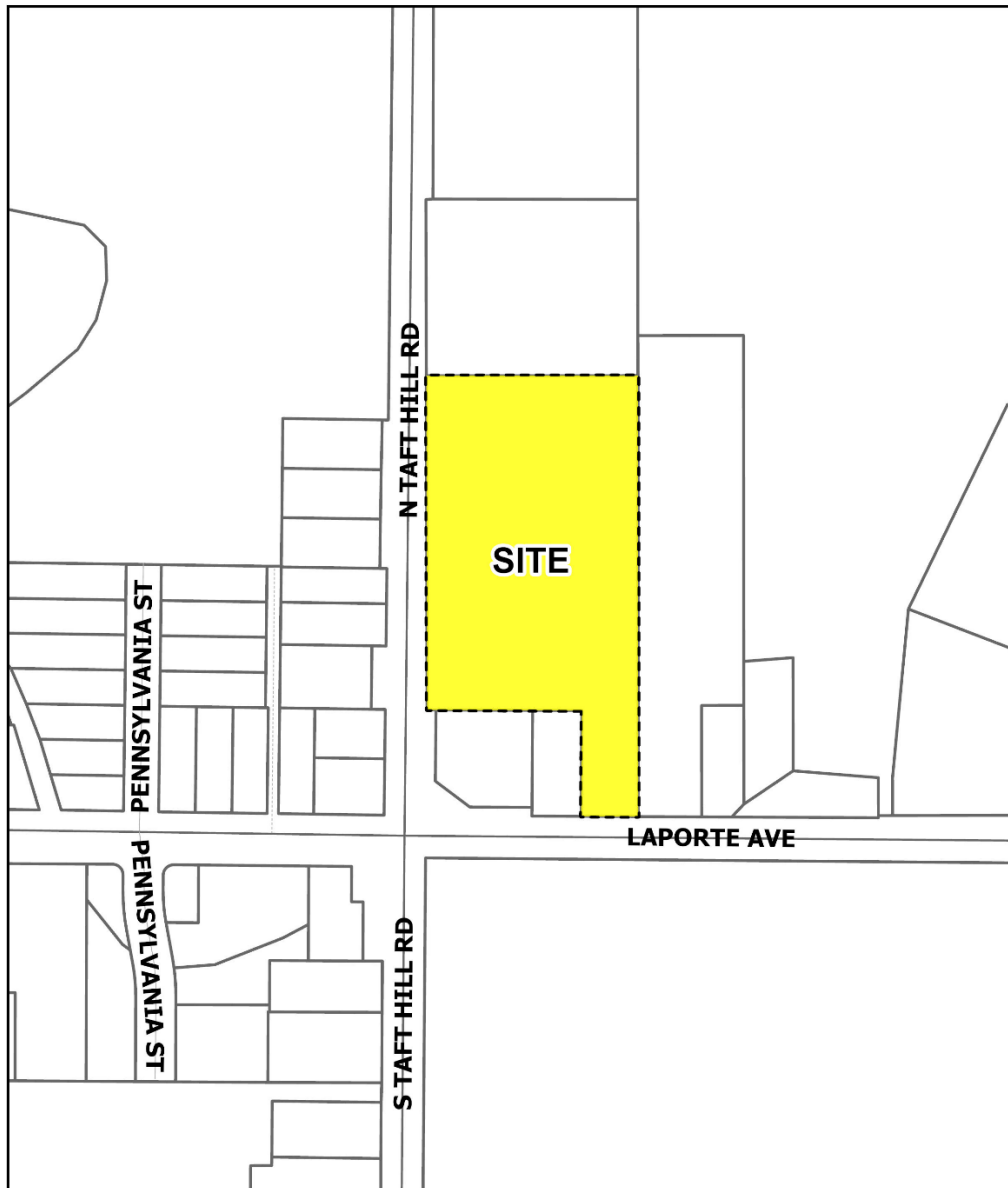
- This is a request for annexation and zoning of approximately 3.368 acres near the NE corner of Laporte Ave and N Taft Hill Rd.

- Requires review and a recommendation to City Council by the Planning and Zoning Commission.
- City Council will consider approval of the annexation and zoning in September 2025.
