PROPOSAL INFORMATION


- This is a request to construct a 226unit multi-family development.
- The project consists of 6 buildings, each 4 stories in height.
- The site is approximately 6.8-acres in size and is located adjacent to an 80foot landscape buffer that adjoins the northbound on-ramp at the I-25 & Prospect Road interchange.
- Site amenities would include a pool, walkway connection to the regional trail, gym and dog park.
- Access would be primarily taken from a new local street (Prospect Ridge) and the future Carriage Parkway to the east of the site.
- Requires review and a decision by the Planning and Zoning Commission at a public hearing.
