PROPOSAL DESCRIPTION

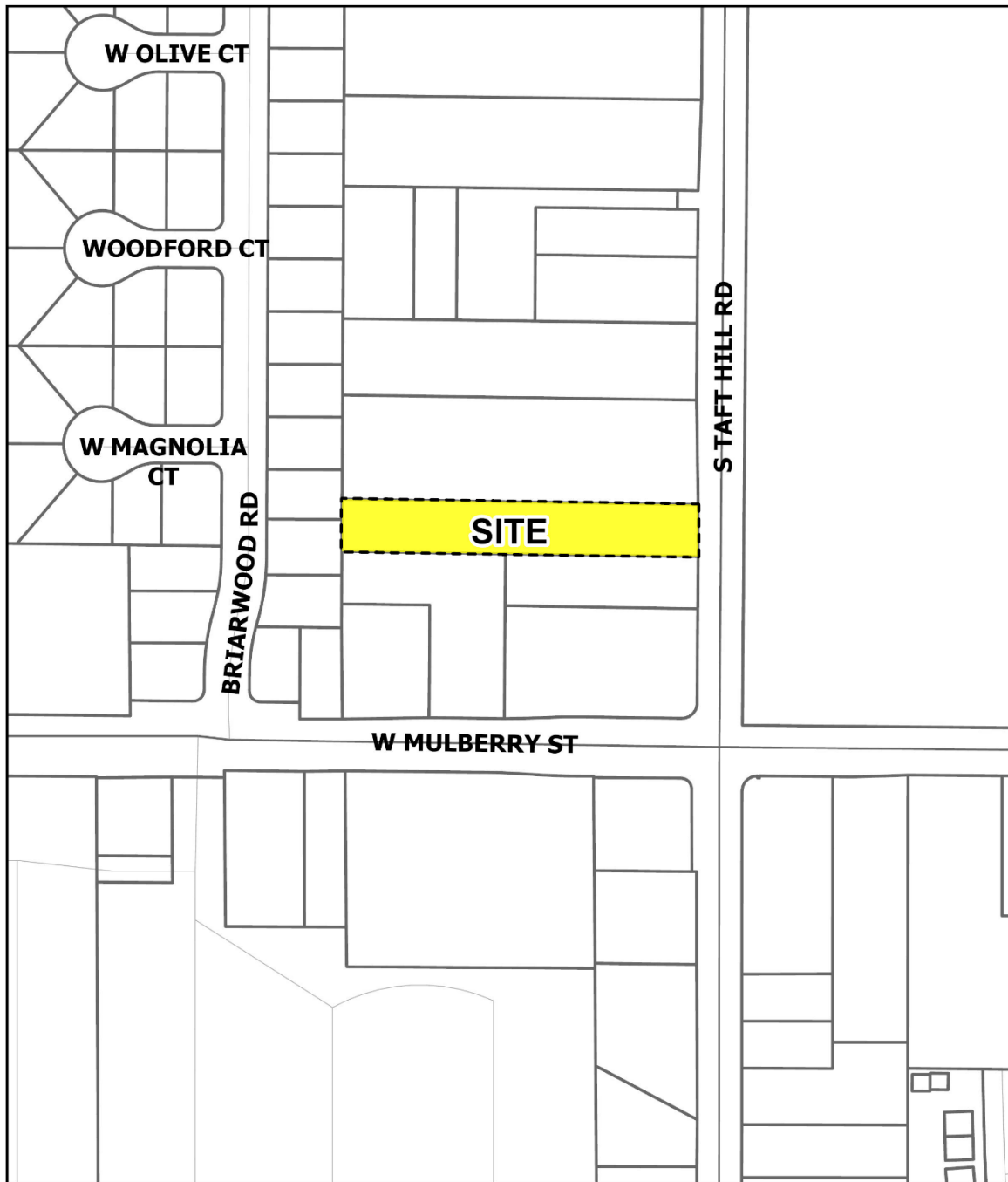
