This letter is being sent to let you know the Planning and Zoning Board will conduct a **virtual public hearing on May 21** to consider a development plan for a childcare center near property you own. Basic information about the plan is to the right and on the back of this letter. A decision regarding the approval or denial of the proposal will be made at the hearing.

City Council has authorized the use of remote technology for select hearings. You can participate over the phone, on the internet, or through the Zoom app on a smartphone, iPad, or computer. You do not need a paid Zoom account to participate. 
- This is a Project Development Plan (PDP) to convert an existing building to a Child Care center.
