

How to Access Public Records of Development Review Projects

All reports, site plans, and applications submitted to the City of Fort Collins as part of the Development Review process are public records and can be accessed online. Use the steps below to find all documents related to a proposal. As a reminder, it can take one to two weeks for documents to be available in the system after they are submitted.
