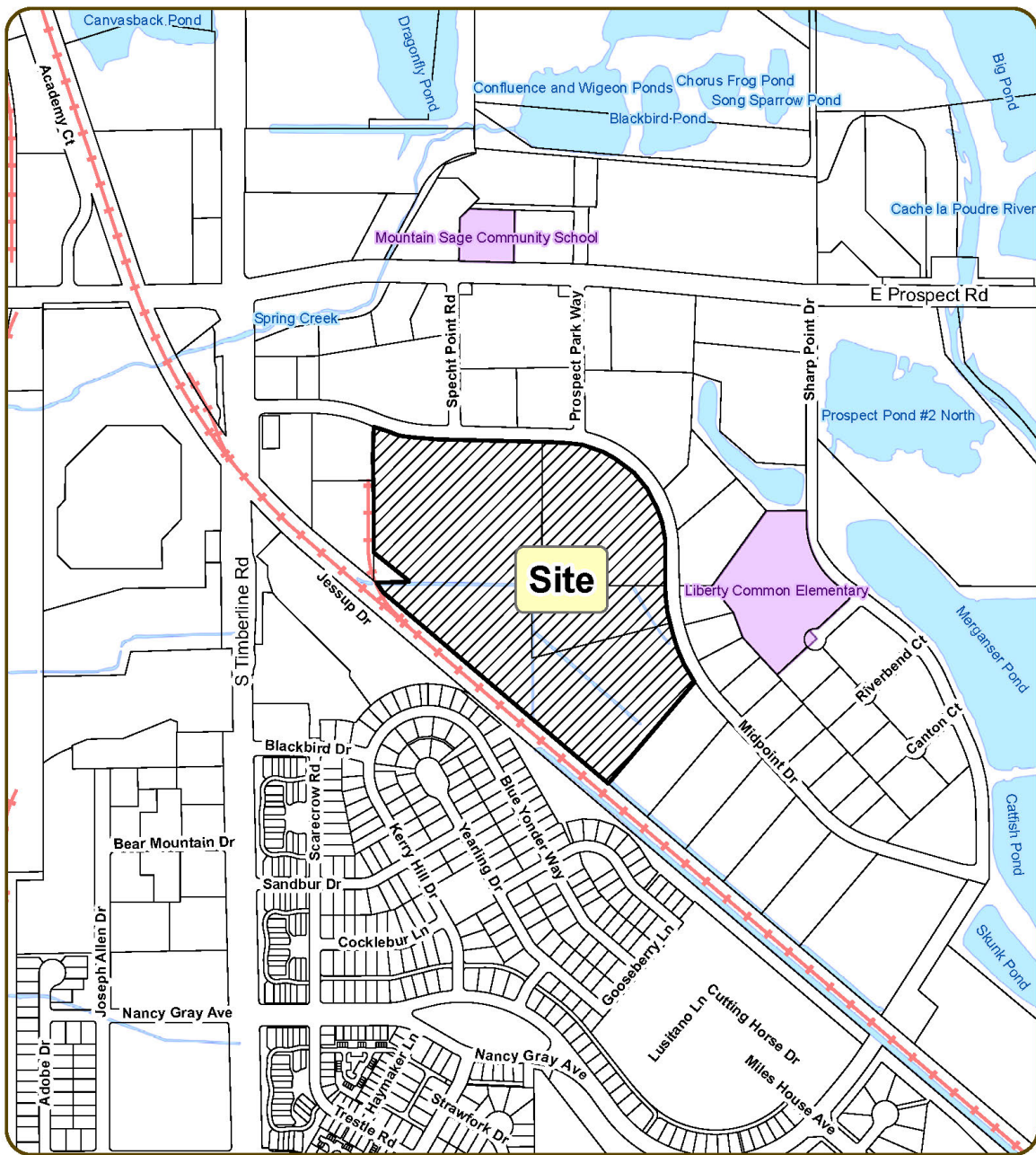

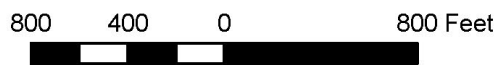

PROPOSAL DESCRIPTION

- This is a request to renovate and add to the existing Larimer County Jail located on Midpoint Drive.
- Additional building space includes a new prison housing unit, a support services building, an interior parking area for patrol cars and a connector to the existing sheriff's building.
- Access is taken from Midpoint Drive.
- The property is within the Employment (E) and Industrial (I) Zone Districts.
