You received this notice because records from the Larimer County Assessor's Office indicate you own property near the proposed development site. ## PROPOSAL DESCRIPTION


- Renovate vacant and dilapidated 1950's-era gas station for a BBQ restaurant.
- Would include new sidewalks with street trees and repaving the site for parking.

- The property is in the Low Density Mixed-Use Neighborhood (LMN) Zone District.
- Several variances are needed to meet today's development standards, to enable re-use of the 1950's development site.
