You can participate over the phone, on the internet, or through the Zoom app on a smartphone, tablet, or computer. The Enclave at Redwood, CDR200049, located east of Redwood Street and north of Suniga Road, (location map on the back of this letter).

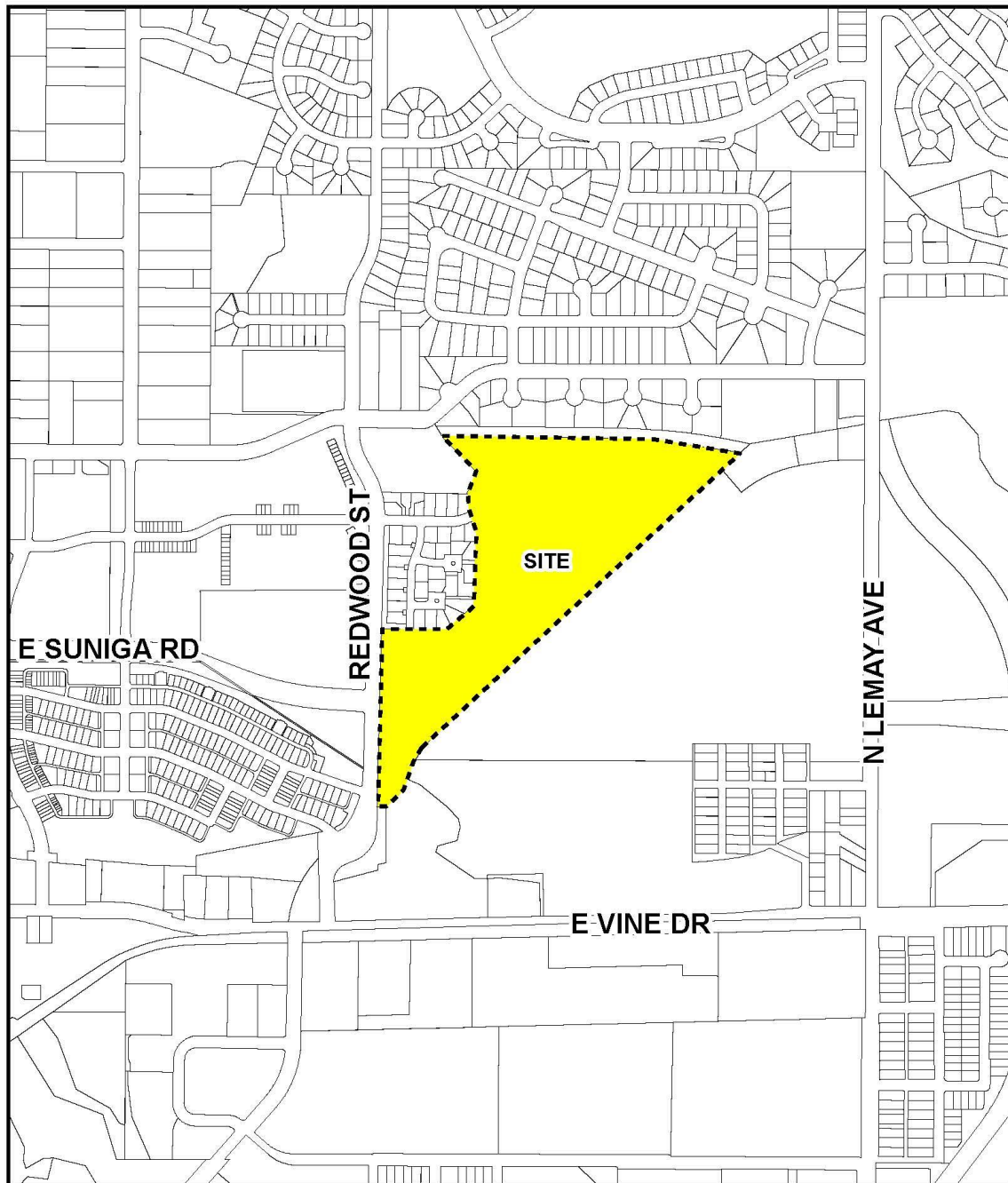

PROPOSAL DESCRIPTION

- This project is on the same site as a former project called The Retreat at Fort Collins PDP.
- This is a request to develop approximately 28 acres into a residential project, including approximately 200-220 dwelling units for sale and rent (mixture of single-family attached/detached and two-family attached townhomes). The proposal also includes 437 parking spaces.
- The project is in the Low Density Mixed-Use Neighborhood (LMN) zone district and is subject to an Administrative (Type 1) review.
- Residents who receive this letter will also receive a letter for the Type I hearing.
