PROPOSAL DESCRIPTION


- Three multifamily residential buildings with about 212 units and with a small commercial space in the building at the corner of Jerome and Suniga.
- 3- and 4-story buildings.
- The site is part of the Old Town North development plan with access from Pascal and Cajetan Streets.
- The Old Town North plan and other adopted plans call for long-term connections to North College Ave.
 A private drive and a walkway spine are proposed to stub to the west boundary.
- Complex floodplain mapping is in process on the site.
