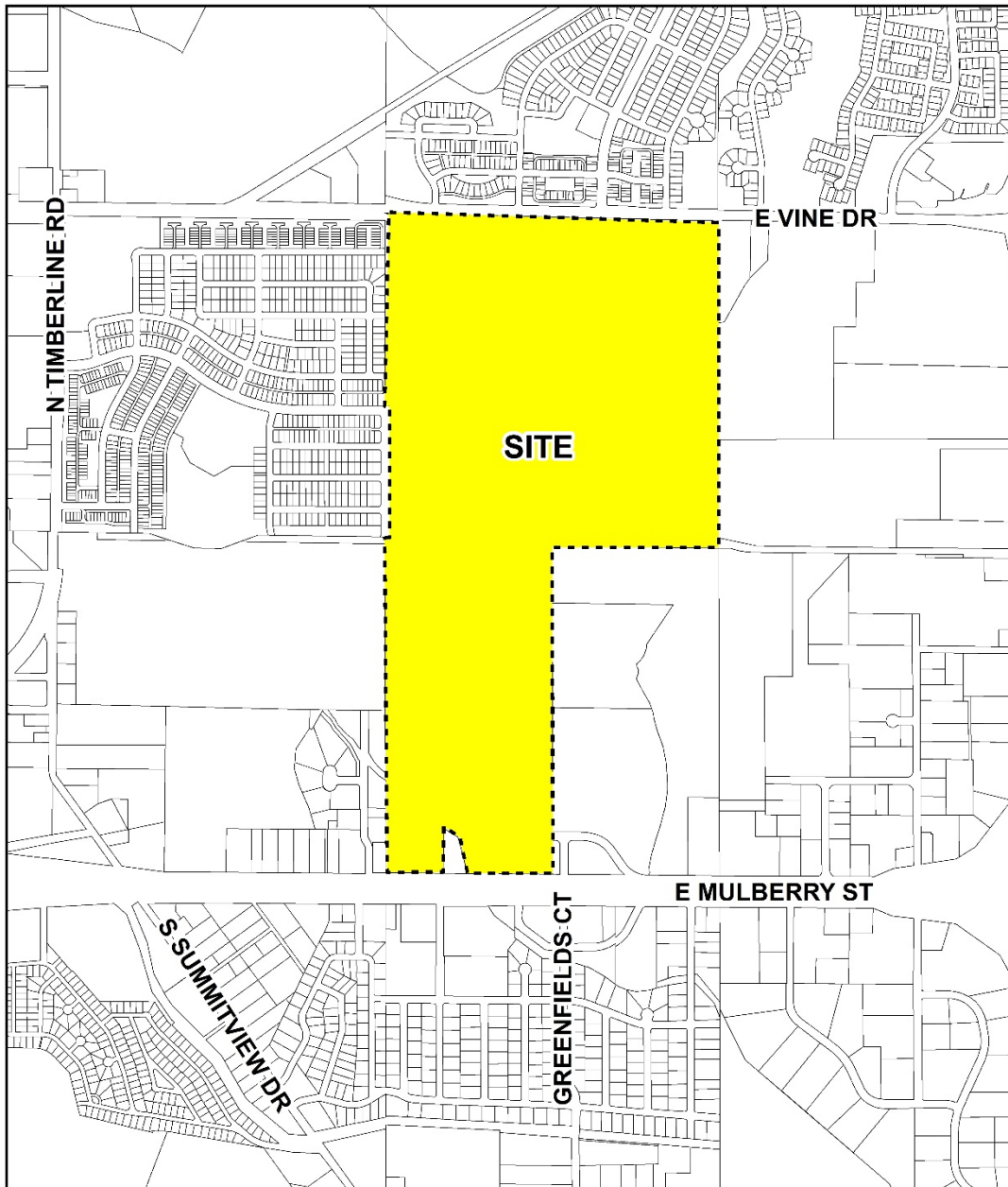

## PROPOSAL DESCRIPTION

- This project represents a Planned Unit Development (PUD) Master Plan on approximately 226 acres.
- The PUD includes a mixed-use neighborhood with approximately 20-30 acres of commercial uses, 1,600 dwelling units, and open space.
- The site will have access from Greenfields Court to the east, which will be extended north to Vine Drive.
- The project is in the Low Density Mixed-Use Neighborhood (LMN), Medium Density Mixed-Use Neighborhood (MMN), Neighborhood Commercial (NC), Employment (E), and General Commercial (CG) zone districts and is subject to a Planning and Zoning Board (Type 2) review.
- Residents who receive this letter will also receive a letter for the Type 2 hearing.
