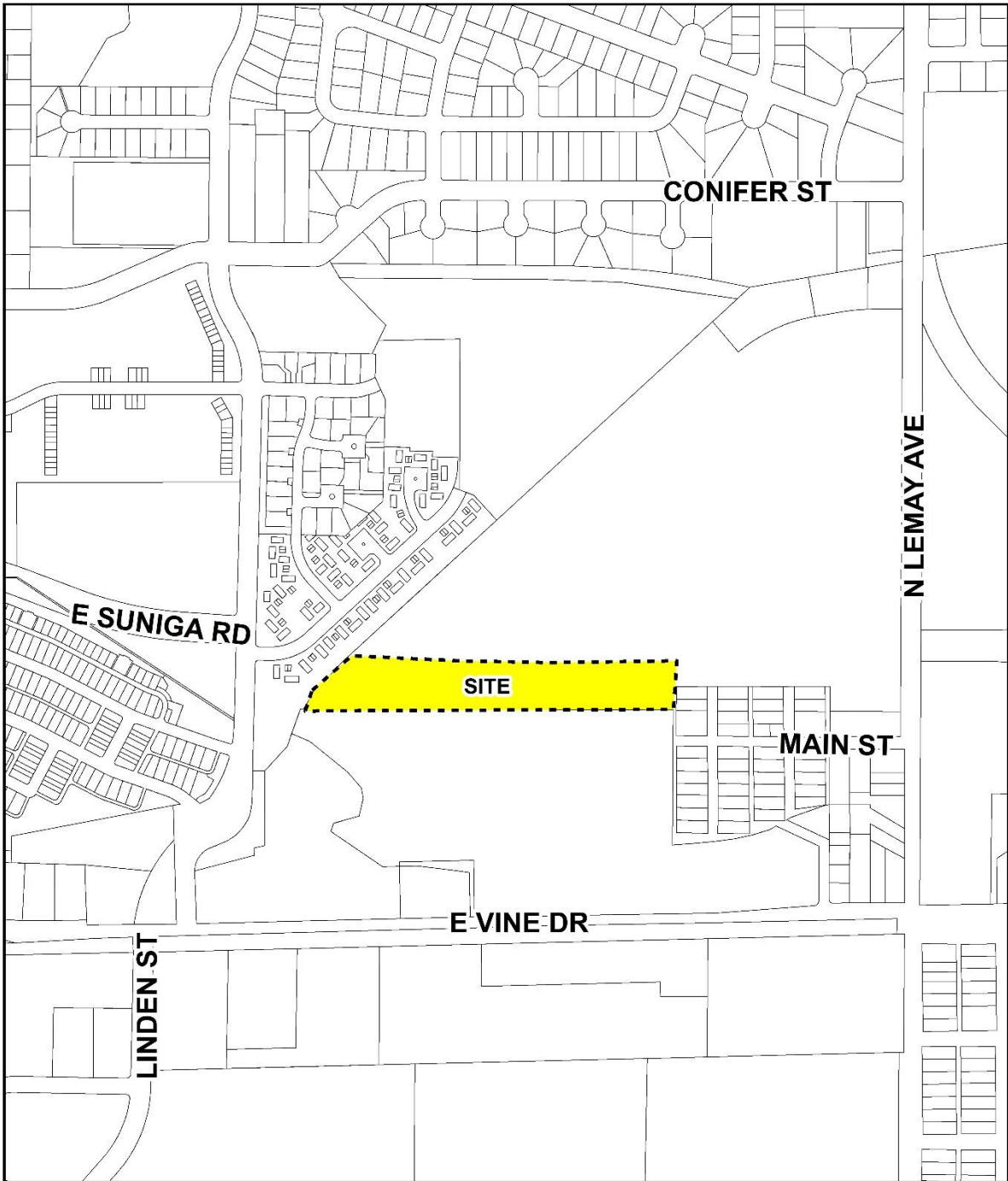

PROPOSAL DESCRIPTION

- This is a proposal to amend an approved Project Development Plan PDP180011 Northfield Filing 1 Expanded.
- The amendment proposes seven 12-unit buildings which are two to three-stories in height.
- Each building will have 12 units for an overall total of 84 units.
- The plan includes a large outdoor amenity area, clubhouse, and connection into the regional trail system along the west side of the site.
- This proposal will require a review and public hearing by the Planning & Zoning Board (P&Z).
- Residents who receive this letter will also receive a letter for the P&Z hearing.
