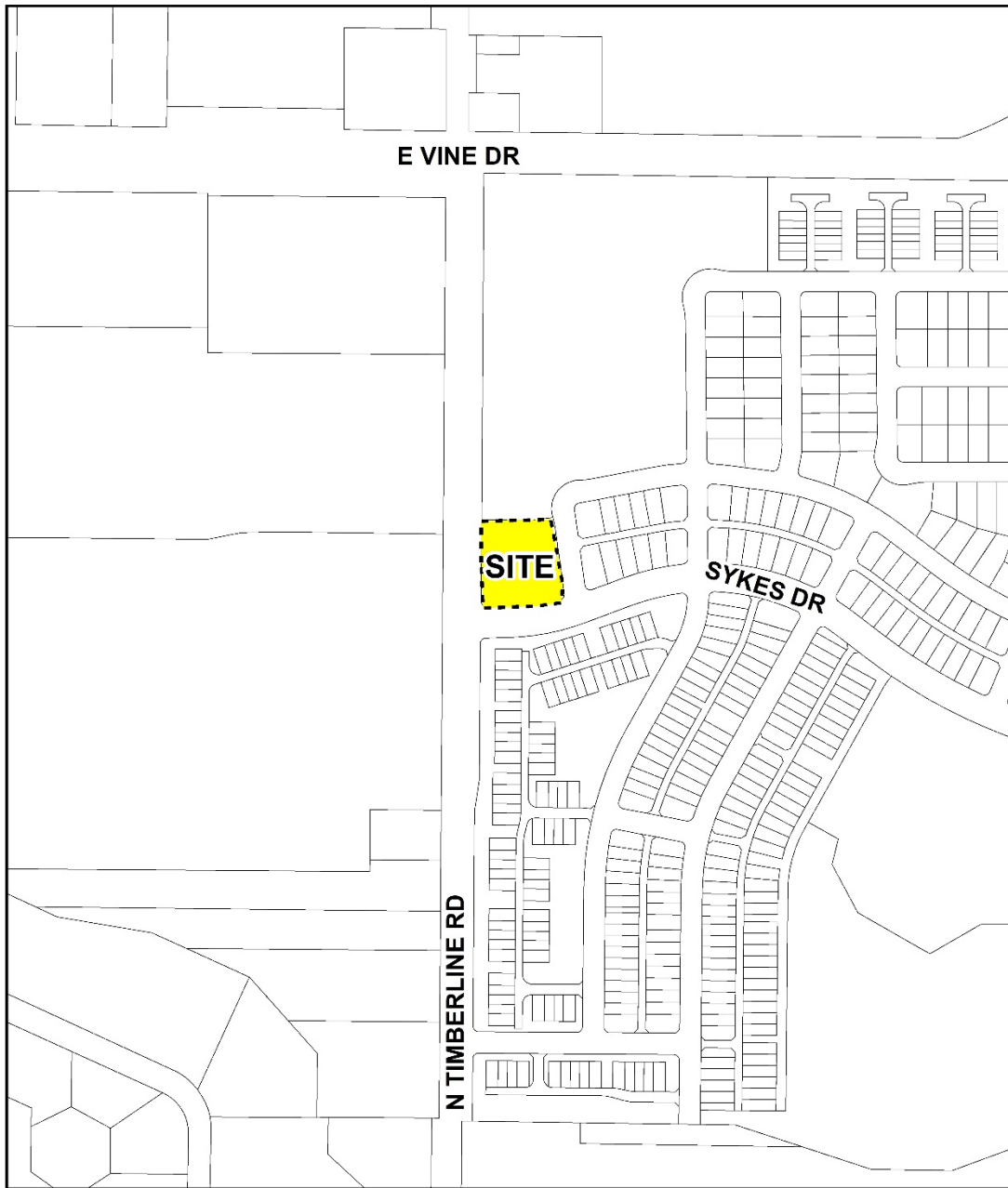

## PROPOSAL DESCRIPTION

- Build a neighborhood center for the Mosaic Community, that includes approximately 4,000 square feet of commercial space as well as a community pool with an affiliated 1,000 square foot building, and a neighborhood open space area.
- Future access will be taken from Conquest Way to the east. The proposal includes 18 parking spaces.
- The project is in the Low Density Mixed-Use Neighborhood (LMN) Zone District and is subject to a (Type 2) Review and public hearing by the Planning & Zoning Board.
- Residents who receive this letter will also receive a letter for the P&Z hearing.
