PROPOSAL DESCRIPTION

- This is a request to establish a 16-resident group home.
- Group homes are licensed, certified and registered by the Colorado Department of Public Health & Environment.
- The project will be required to provide two parking spaces for every three employees, and in addition, one parking space for each four adult residents, unless residents are prohibited from owning or operating personal automobiles.
- The project is in the Low Density Residential (RL) Zone District and is subject to a (Type 2) Review and public hearing by the Planning & Zoning Board.
- Residents who receive this letter will also receive a letter for the P&Z hearing.
