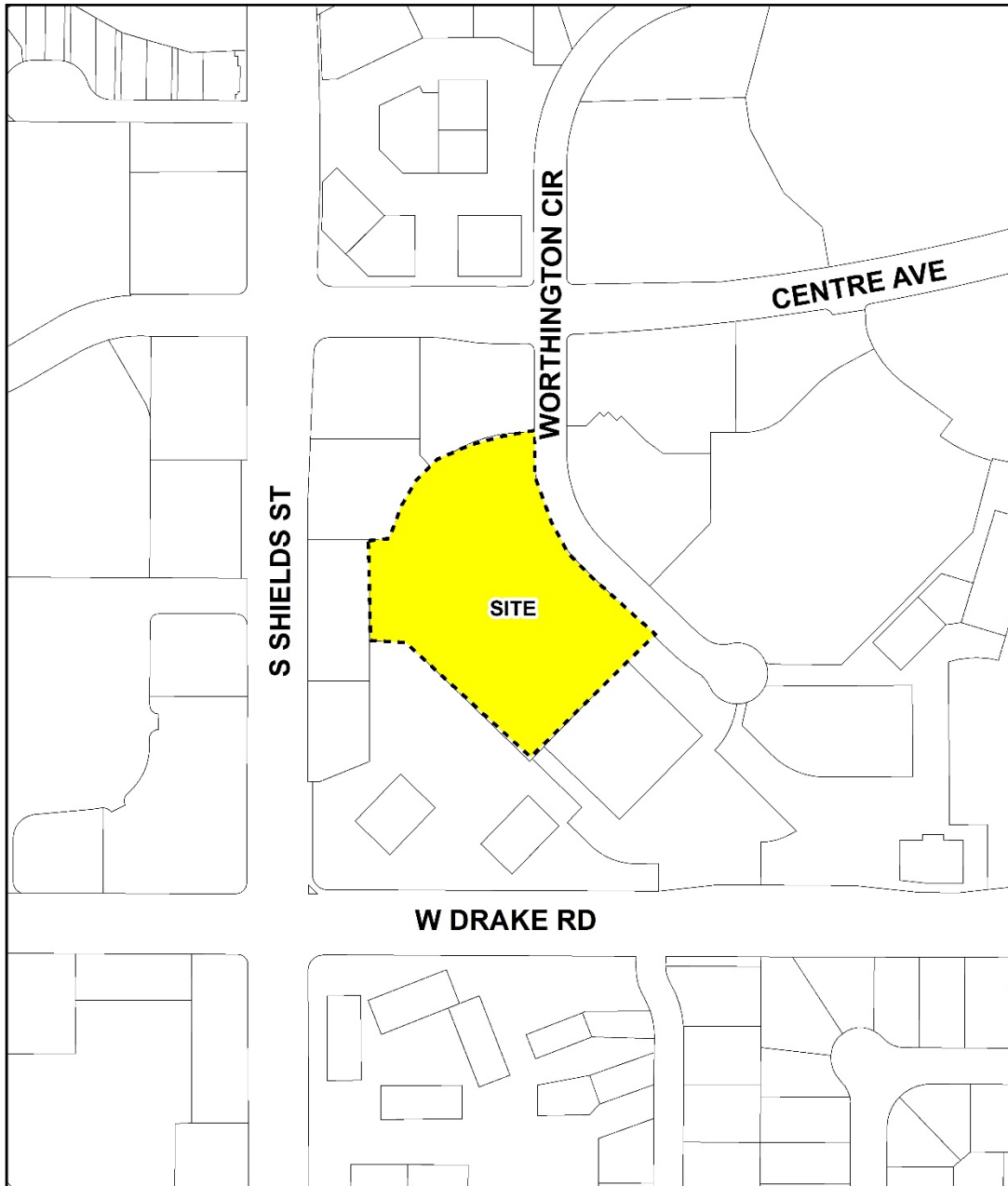
PROPOSAL DESCRIPTION
