

- ODP helps determine broad development characteristics for landuses, transportation connections, density, and more.
- The proposal includes primarily residential land-uses including singlefamily attached, multifamily, and mixed-use dwellings.
- The project is in the Harmony Corridor (HC) Zone District and is subject to a (Type 2) Review and public hearing by the Planning & Zoning Commission.
- Residents who receive this letter will also receive a letter for the P&Z hearing.
