

PROPOSAL DESCRIPTION

- Request for plan amendment and rezone for the property from Industrial to Medium Density Mixed-Use Neighborhood and General Commercial.
- Rezoning would be the first step towards development of 324 multifamily units with 543 parking spaces proposed on the site.
- The rezoning would be subject to review and recommendation by the Planning and Zoning Commission and decision by City Council.
