North Weld County and East Larimer County Water Districts Water Transmission Pipeline Project (NEWT 3), CDR200001 From N Timberline Rd and E Suniga Rd to E of I-25 (Please see map on the reverse).

PROPOSAL DESCRIPTION

- This is a request to build 28,300 feet (5.35 miles) of new potable water pipeline.
- The pipeline project runs approximately east west beginning at N Timberline Rd and E Suniga Rd and ending in Larimer County at Ridgeview Lane and West County Rd 13.
- As a public facility, this proposal is subject to a Site Plan Advisory Review (SPAR) by the Planning & Zoning Board.
- A portion of the project occurs outside of Fort Collins City limits. Only affected areas within City limits will be evaluated during the SPAR process
- Residents who receive this letter will also receive a letter for the Planning & Zoning Board advisory review hearing.
