

PROPOSAL DESCRIPTION

- This is a request to develop 176 multifamily dwelling units for District 3 of the proposed Mulberry – Greenfields PUD with four distinctive building types proposed, ranging from 2-3 stories in height.
- Proposed approximate 60 off-street parking spaces along with garage spaces for each unit. Future access will be taken from the future One Dr to the west which will be accessed by the future extensions of International Blvd and Sykes Dr.
- This proposal will require a Type I Review and administrative public hearing.
