
#### PROPOSAL DESCRIPTION

- Two parts are proposed:

   remove 4 existing houses near the Shields & Westward corner, and build a new multi-family development; and
   develop a subdivision for detached houses in the vacant western extension of the property on Del Mar St.
- 3-story and 2-story multi-family buildings are proposed.
- Zoning requires a 60-foot setback from Shields St. and a Modification is proposed to allow a 20-foot setback.
- The site is in the Neighborhood Conservation Buffer (NCB) and Low Density Residential (RL) zone districts.
- This proposal will require a review and public hearing by the Planning & Zoning Commission (P&Z).
- Residents who receive this letter will also receive a letter for the P&Z hearing.
