

PROPOSAL DESCRIPTION

- Construct 254 multi-family dwellings and approximately 442 parking spaces on Tracts D, E and L of the Hansen Farm subdivision. Access is proposed from the planned Twisted Root Dr to the north and Zephyr Rd to the south.
- The site is in the Medium Density Mixed-Use Neighborhoods (MMN) Zone District.
- This proposal will require a review and public hearing by the Planning & Zoning Commission (P&Z).
 Residents who receive this letter will also receive a letter for the P&Z hearing.
