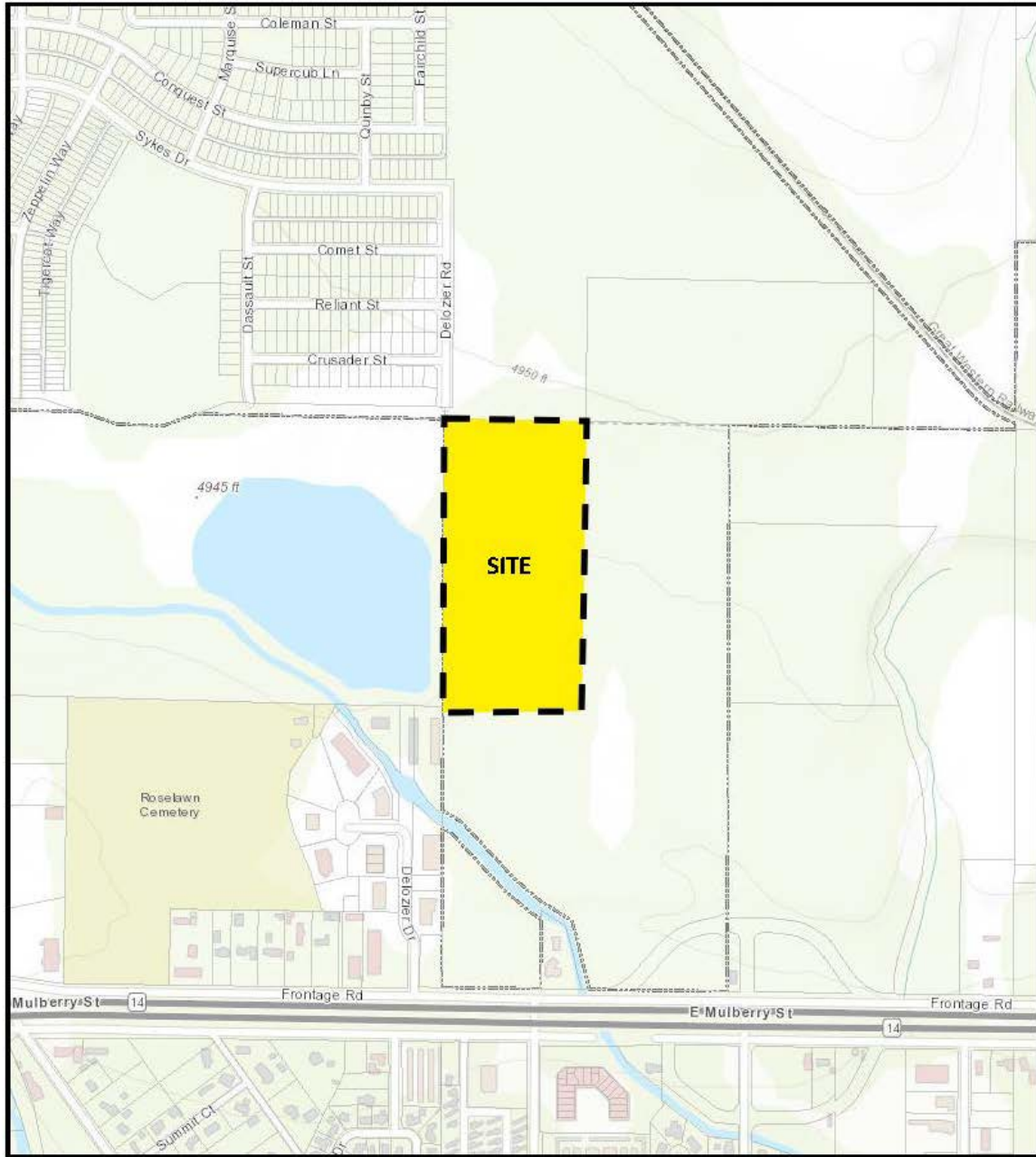

PROPOSAL DESCRIPTION

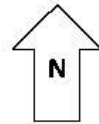
- This is a request to develop 360 multi-family dwelling units within 15, 3-story buildings, and 670 parking spaces in District 2 of the PUD, on 18.3 acres. At least 264 of the dwelling units are intended to be affordable rental units. Future access will be taken from future International Blvd directly to the north, and additional streets to the east and south, as part of the overall PUD.
- The site is within the Low Density Mixed Use Neighborhood (LMN) and Medium Density Mixed-Use Neighborhood (MMN) zone districts and will require a review and public hearing by the Planning & Zoning Commission (P&Z). Residents who receive this letter will also receive a letter for the P&Z hearing.
