This letter is to invite you to a **virtual neighborhood meeting on May 12th for a proposed 136 dwelling unit residential development including neighborhood center, group home, community garden, and place of worship project** located on vacant property, generally NW of W. Elizabeth Street and Kimball Road near property you own. At the meeting, you can learn more about the development proposal. Basic information about this proposed development is to the right and on the back of this letter.

City Council has authorized the use of remote technology for select neighborhood meetings. You can participate over the phone, on the internet, or through the Zoom app on a smartphone, tablet, or computer. 
