Elizabeth Street and Kimball Road near property you own. At the meeting, you can learn more about the development proposal. Basic information about this proposed development is to the right and on the back of this letter.

You can participate over the phone, on the internet, or through the Zoom app on a smartphone, tablet, or computer. 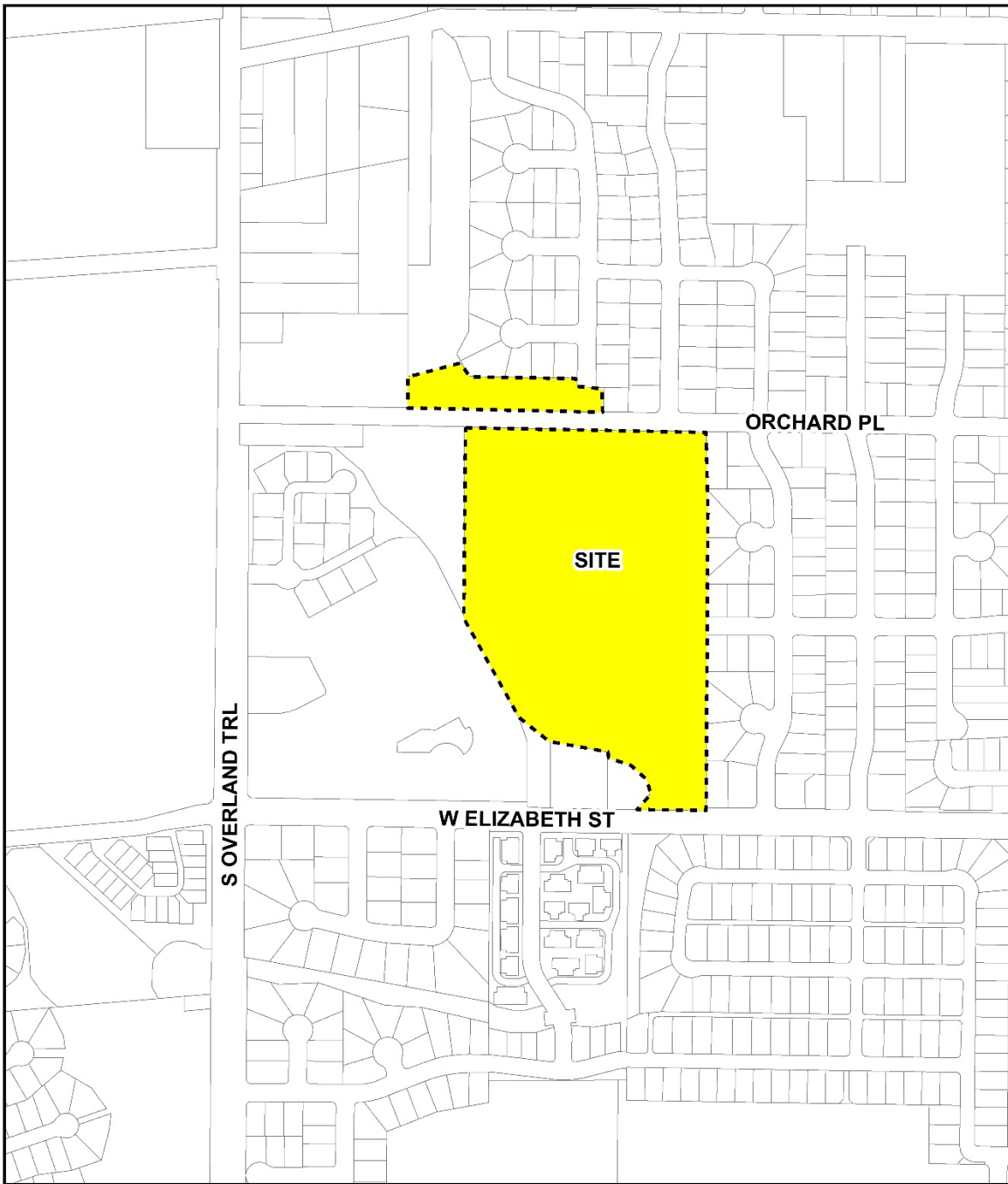

- The site is in the Low Density Residential (RL) and Low Density Mixed-Use Neighborhood (LMN) zone districts and will require a review and public hearing by the Planning & Zoning Commission (P&Z).
