This letter is to invite you to a **virtual neighborhood meeting on May 16th for a proposed 220 unit residential development**. This is the first phase of the Ziegler-Corbett Overall Development Plan and proposes a combination of duplex, townhome, multifamily condominium, and live-work units. The project site is located west of Ziegler Road between Front Range Village to the south and The English Ranch subdivision to the north. At the meeting, you can learn more about the development proposal. Basic information about this proposed development is to the right and on the back of this letter.

City Council has authorized the use of remote technology for select neighborhood meetings. You can participate over the phone, on the internet, or through the Zoom app on a smartphone, tablet, or computer. 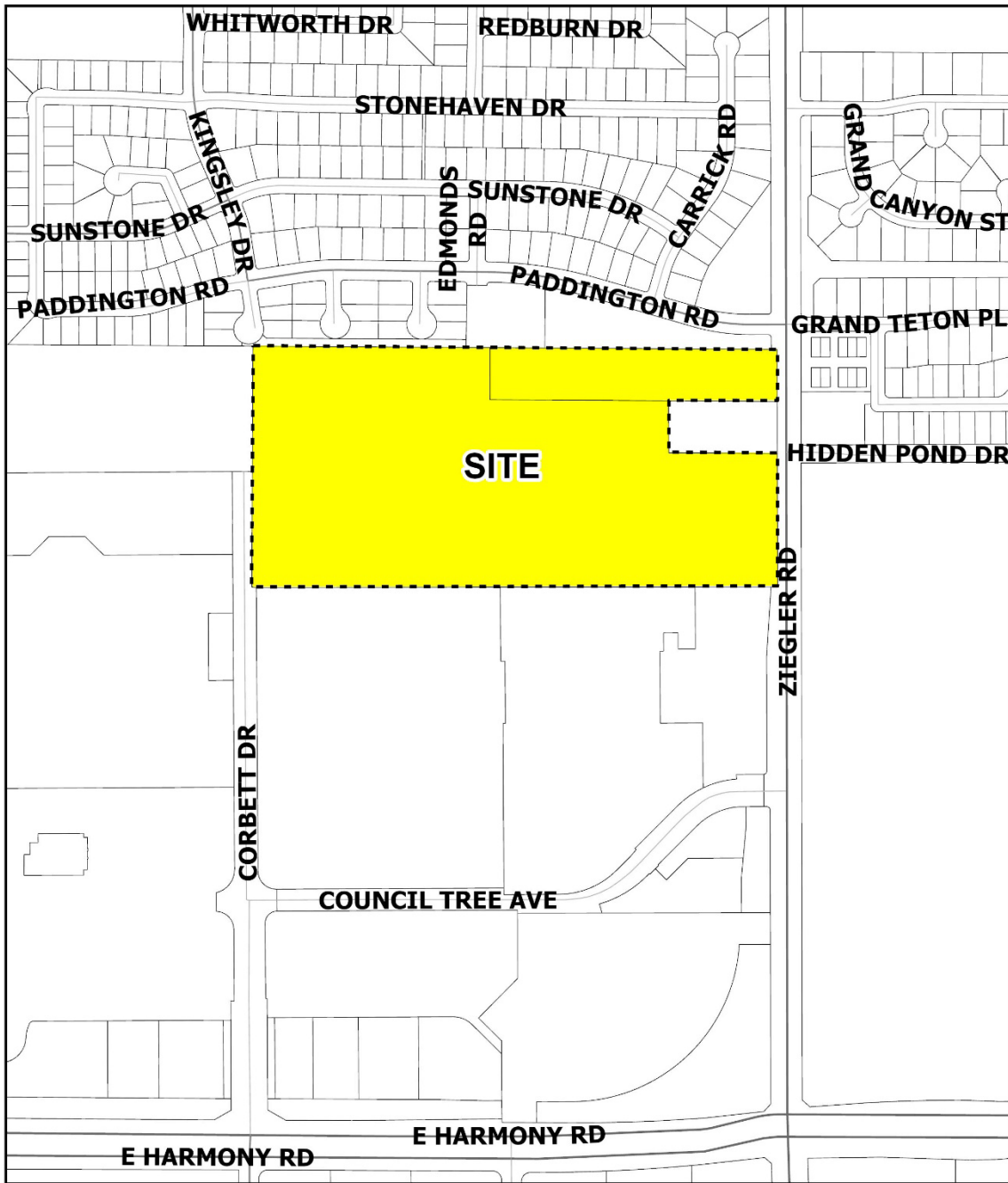
