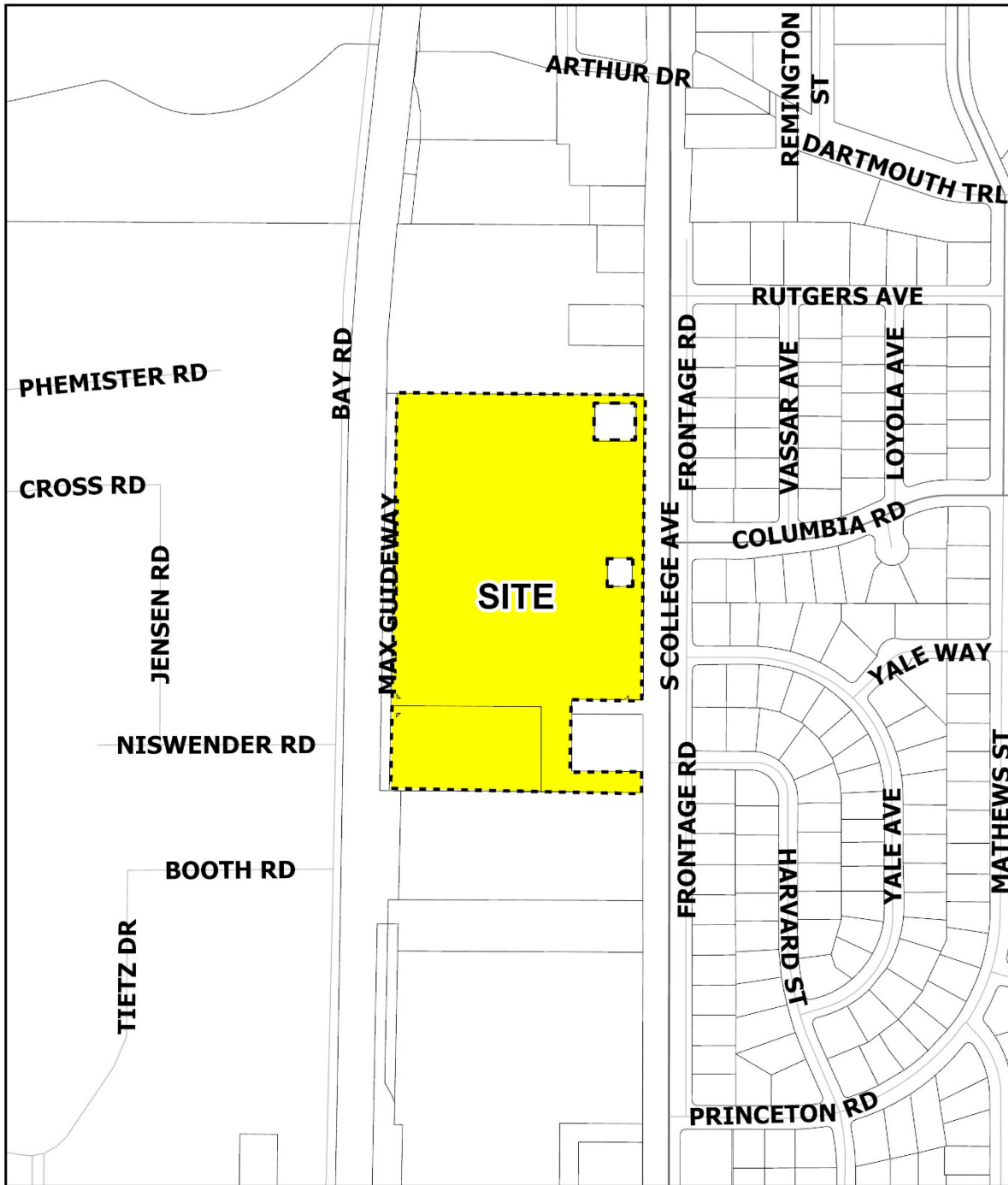

PROPOSAL DESCRIPTION

- This is a proposal to demolish King Soopers, Car Toys, Visionworks, and former Performance Cycle building to construct a 4-story, 224-unit multi-family building.
- The plan proposes 192 parking spaces and to maintain existing site circulation patterns in-front and behind the building.
- The site is in the General Commercial (CG) Zone District and the Transit Oriented Development (TOD) Zoning Overlay.
- This proposal will require a review and public hearing by the Planning & Zoning Commission (P&Z).
- Residents who receive this letter will also receive a letter for the P&Z hearing.
