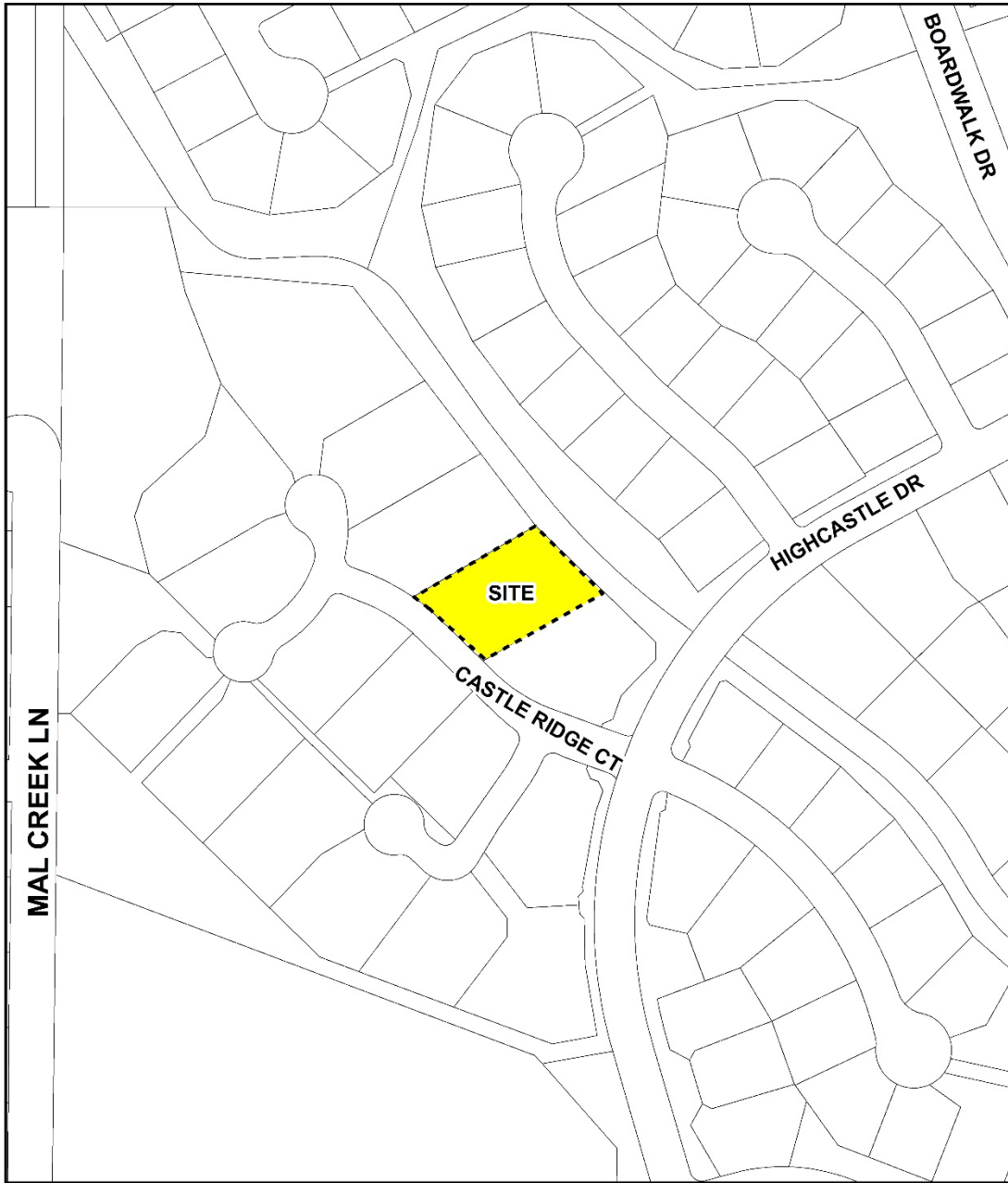
PROPOSAL DESCRIPTION
