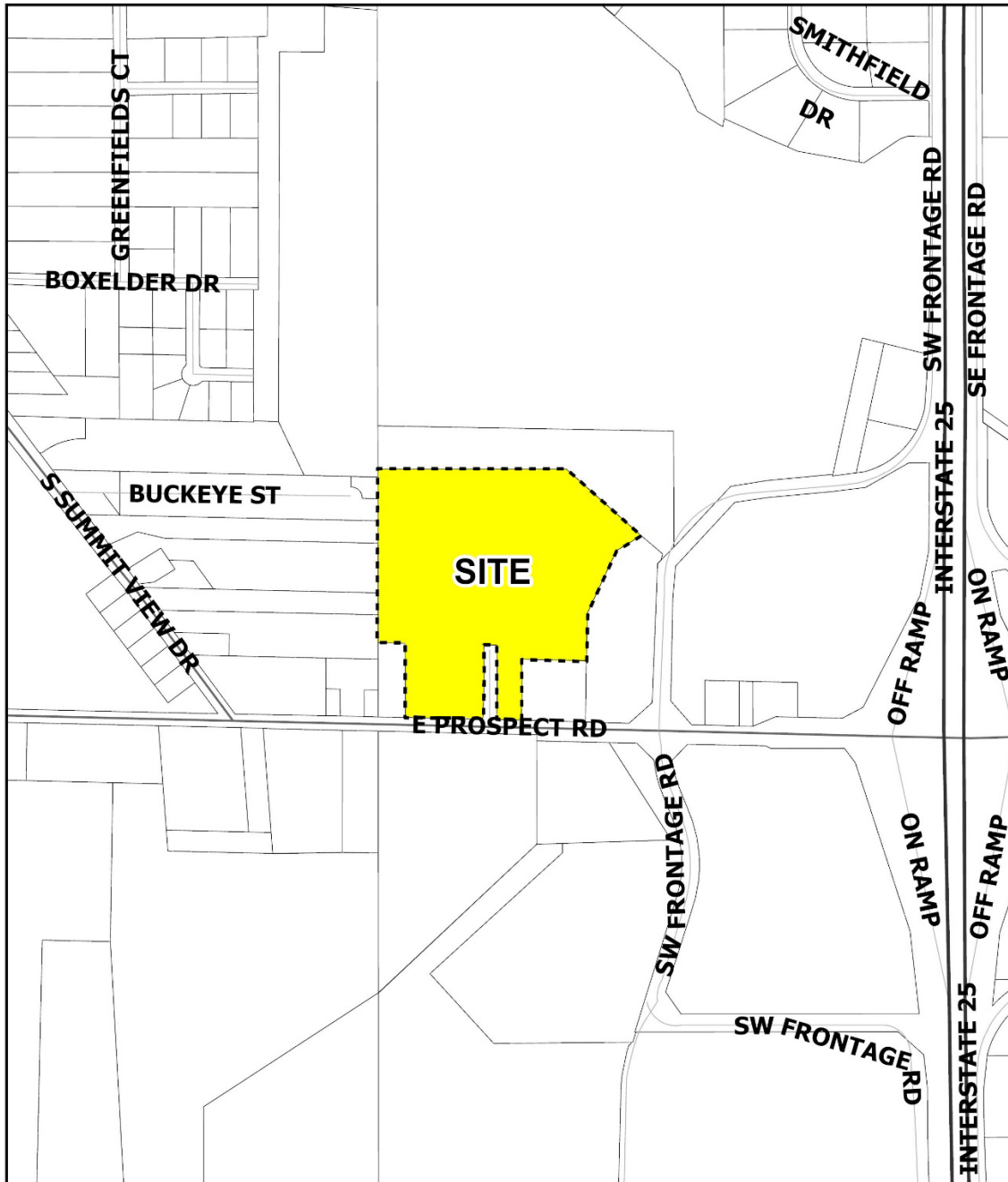

- The site is in the Medium Density Mixed-Use Neighborhood (MMN) zone district.
- This proposal will require a review and public hearing by the Planning & Zoning Commission (P&Z).
