This letter is to invite you to a **virtual neighborhood meeting on October 19 for a proposed site** on West Mountain Avenue near property you own for a **temporary overflow shelter for men experiencing homelessness**. At the meeting, you can learn more about the proposal. Specific information about this proposal is to the right and on the back of this letter.

City Council has authorized the use of remote technology for select neighborhood meetings. You can participate over the phone, on the internet, or through the Zoom app on a smartphone, tablet, or computer. You do not need a paid Zoom account to participate. **Virtual participation information will be available** at fcgov.com/developmentreview/proposals at least 48 hours in advance of the meeting. You received this notice because records from the Larimer County Assessor's Office indicate you own property near the proposed site.
