This letter is to invite you to a **hybrid neighborhood meeting on December 14th for a proposal to develop 416 multi-family units** on Tract FF of the Mulberry & Greenfields Planned Unit Development (PUD), near property you own. **The neighborhood meeting will be held in-person at 281 N. College Avenue in Conference Rooms A-C as well as virtually through Zoom.** At the meeting, you can learn more about the development proposal. Basic information about this proposed development is to the right and on the back of this letter.


