

PROPOSAL DESCRIPTION

- This is a request to build an entertainment facility at the SE corner of W Boardwalk Dr and S Mason St. The proposed building will be two-stories with third level roof terrace gathering areas. Also, develop a parking lot at 3915 & 3935 S Mason St as support for the proposed events center.
- The site is in the General Commercial District (C-G) zone district
- This proposal will require a review and public hearing by the Planning & Zoning Commission (P&Z).
