#### **PROPOSAL DESCRIPTION**

- This is a proposal to create a 55-lot single-family detached subdivision on approximately 12-acres of land.
- The proposal includes a 1.7-acre park and would construct a portion of a regional trail that would eventually provide connection into the Spring Creek Trail system.
- The development is required to create a street and block system that extends West Swallow Road, Hull Street and Hyline Drive into the site for future access.
- The site is in the Low Density Mixed-Use Neighborhood (LMN) zone district.
- This proposal will require a review and public hearing by an Administrative Hearing Officer.
- Residents who receive this letter will also receive a letter for the administrative hearing.
