

PROPOSAL DESCRIPTION

- This is a proposal to develop the site with multi-family dwellings with 20% proposed to be affordable.
- The proposed development is for 7 multi-family buildings containing 20 dwelling units for a total of 140 units.
- It will also include 219 parking spaces (combination of garage, on-site, and on-street parking).
- Access will be taken from the proposed 4th St to the east which would be accessed from Buckingham St to the north and Logan St to the south.
- The property is located within the Industrial (I) zone district. There was a previous neighborhood meeting held about the proposed rezoning to Neighborhood Conservation Buffer (NCB) zone district.
- This proposal will be subject to a public hearing.
- Residents who receive this letter will also receive a letter for the public hearing.
