This letter is to invite you to an in-person neighborhood meeting on June 22nd for a proposed multi-family neighborhood development, near property you own. The meeting will be held at 281 N. College Ave. Conference Rooms A-C. There will be no virtual participation available for this meeting.

This is the second neighborhood meeting regarding this proposal. During the first meeting, the name of the project was Watermark on Willox, but it has since been changed to The Collective.

This meeting will take a different format from the previous meeting. The purpose of this meeting is for neighbors to create a comment letter to the decision maker on this proposal. City staff will be in attendance to help facilitate the meeting and provide expertise in support. The applicant will also be in attendance primarily to listen to neighborhood concerns and ideas.

You received this notice because records from the Larimer County Assessor's Office indicate you own property near the proposed development site. Because of the lag time in recordkeeping, or because of rental situations, some neighbors may be missed. Please feel free to notify your neighbors of the neighborhood meeting so they can attend. If you own or manage an apartment building, please post this notice in a common area so your residents can participate.
