Sonders Village, CDR230014, east of Turnberry Road and north of Richards Lake Road



#### PROPOSAL DESCRIPTION

- This is a proposal to construct a 462-unit residential neighborhood that includes a mix of attached and detached residential units, with development pads for future affordable housing, independent living, and multi-family housing.
- The project proposes a 2-acre neighborhood center that would contain neighborhood serving uses such as coffee shop, medical office, retail, or other similar uses.
- This is a continuation of and is immediately east of the Sonders community formerly known as Waters Edge.
- The site is in the Low Density Mixed-Use Neighborhood (LMN)
- This proposal will require a review and public hearing by the Planning & Zoning Commission (P&Z).
- Residents who receive this letter will also receive a letter for the P&Z hearing.
