

#### PROPOSAL DESCRIPTION

- The two-story building would have about 7,200 sq. ft. of commercial space, and 10 dwelling units.
- A plan would include parking and landscaping. Any lighting would be limited per City code.
- The site is in the Low Density Mixed Use Neighborhood (LMN) zone district, which encourages this type of use as a 'Neighborhood Center'.
- This proposal would require a public hearing by the Planning & Zoning Commission (P&Z).
- Residents who receive this letter would also receive letters for that public hearing.
