# PROPOSAL NAME AND LOCATION: Strauss Lakes, PDR240002



### PROPOSAL DESCRIPTION:

- Develop a walkable mixed-use neighborhood with a 6.91-ac neighborhood commercial area, approximately 1300 dwelling units, trails, neighborhood parks, and open space, and include affordable and attainable housing.
- Access into the neighborhood would be from Horsetooth Rd. & Ziegler Rd.
- Proposed zoning includes Low Density Mixed-Use Neighborhood (LMN), Medium Density Mixed-Use Neighborhood (MMN), and Neighborhood Commercial (N-C).
- Annexation would be required.
- Residents who receive this letter will also receive a letter for future development-related hearings.
