This letter is being sent to let you know the Planning and Zoning Board will conduct a **virtual public hearing on June 18** to consider a development plan near property you own. Basic information about the plan is to the right and on the back of this letter. A decision regarding the approval or denial of the proposal will be made at the hearing.

City Council has authorized the use of remote technology for select hearings. You can participate over the phone, on the internet, or through the Zoom app on a smartphone, iPad, or computer. **Virtual participation information will be available at <u>fcgov.com/developmentreview/agendas</u> at least 48 hours in advance of the meeting.** You do not need a paid Zoom account to participate. If you would like to test the Zoom interface, test meetings will be held on Tuesdays and Thursdays from 12:30-1:00 PM MST through mid-June. You received this notice because records from the Larimer County Assessor's Office indicate you own property near the proposed development site. If you own or manage an apartment building, please post this notice in a common area so your residents can participate.

PROPOSAL INFORMATION


- This is a request to develop 14 multi-family, 2-story condo buildings, each with 8 units, for a total of 112 dwelling units.
- The site includes 190 vehicle parking spaces, and 272 bicycle parking spaces for the residential units.
- Access to the site is provided from Conquest Way to the south, and Vicot Way to the east.
- The project is subject to a Type II review and public hearing by the Planning and Zoning Board.

ZONING INFORMATION

 The proposed zoning is Low Density Mixed-Use Neighborhoods (L-M-N) Zone District.
