## PROPOSAL DESCRIPTION

- This is a request to develop the remaining vacant tract in East Ridge to include 14, two-story condo buildings (five units per building).
- Each condo unit will have garage parking spaces, and approximately 37 surface parking spaces are provided on site for guest parking.
- Primary access to the site is from Sykes Drive and Vicot Way, via N. Timberline Road.
