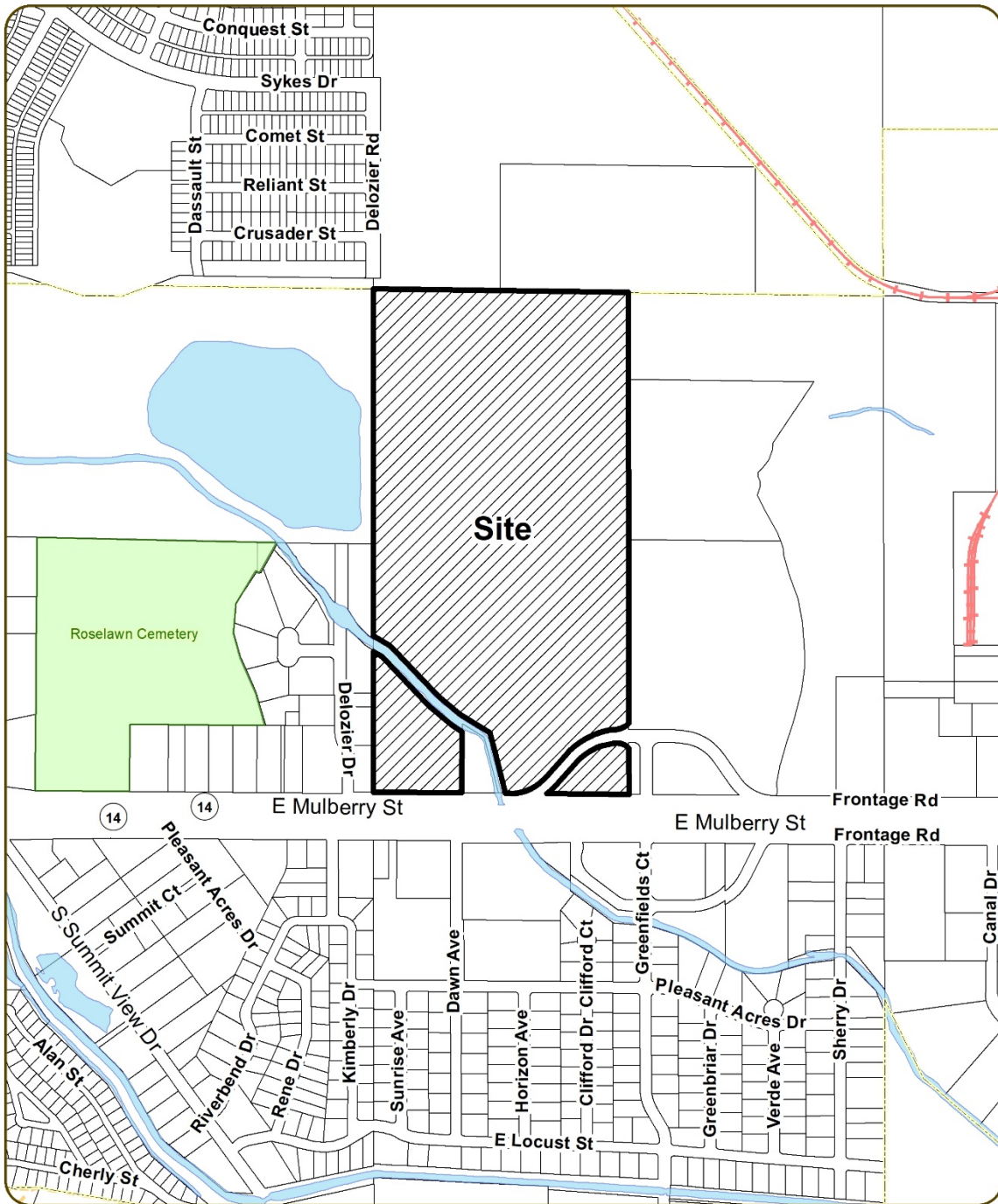
PROPOSAL DESCRIPTION
