

## PROPOSAL DESCRIPTION

- This is a proposal to construct a middle/high school located northeast of I-25 and East Prospect Road.
- Facility will host both a middle school (grades 6-8) and high school (grades 9-12).
- Site will include eight athletic fields and tennis courts.
- Primary site access is proposed off of Prospect Road.
- Site is 100 acres in size.
