Dear Property Owner or Resident,

The City of Fort Collins (City) is hosting a public meeting to inform the community of the City's planned response to the annual need for Winter Overflow Shelter for persons experiencing homelessness. During the cold weather months, the two area homeless shelters cannot meet the demand for overnight shelter. Annually, community partners work to expand shelter capacity to meet this increased demand. The response usually involves increasing capacity on site at the two shelters, activating the Seasonal Overflow Shelter located at Community of Christ Church (220 E. Oak St), and using nightly warming centers. Details of the 2019-2020 winter overflow shelter plan will be provided at this meeting.

**Where: Community of Christ Church, 220 E. Oak Street, Fort Collins CO 80524**

**Who: City Staff and partner agency representatives will present the 2019-2020 response plan**

This meeting will be to discuss the proposed activation of the Seasonal Overflow Shelter (SOS) as required by the City's Land Use Code as well as to inform the general public of the overall response plan.

While neighbors of the SOS will receive this letter, all interested community members are invited to attend. The City will publicize this meeting generally, and you may invite anyone you wish to attend as well. We hope you will attend!
