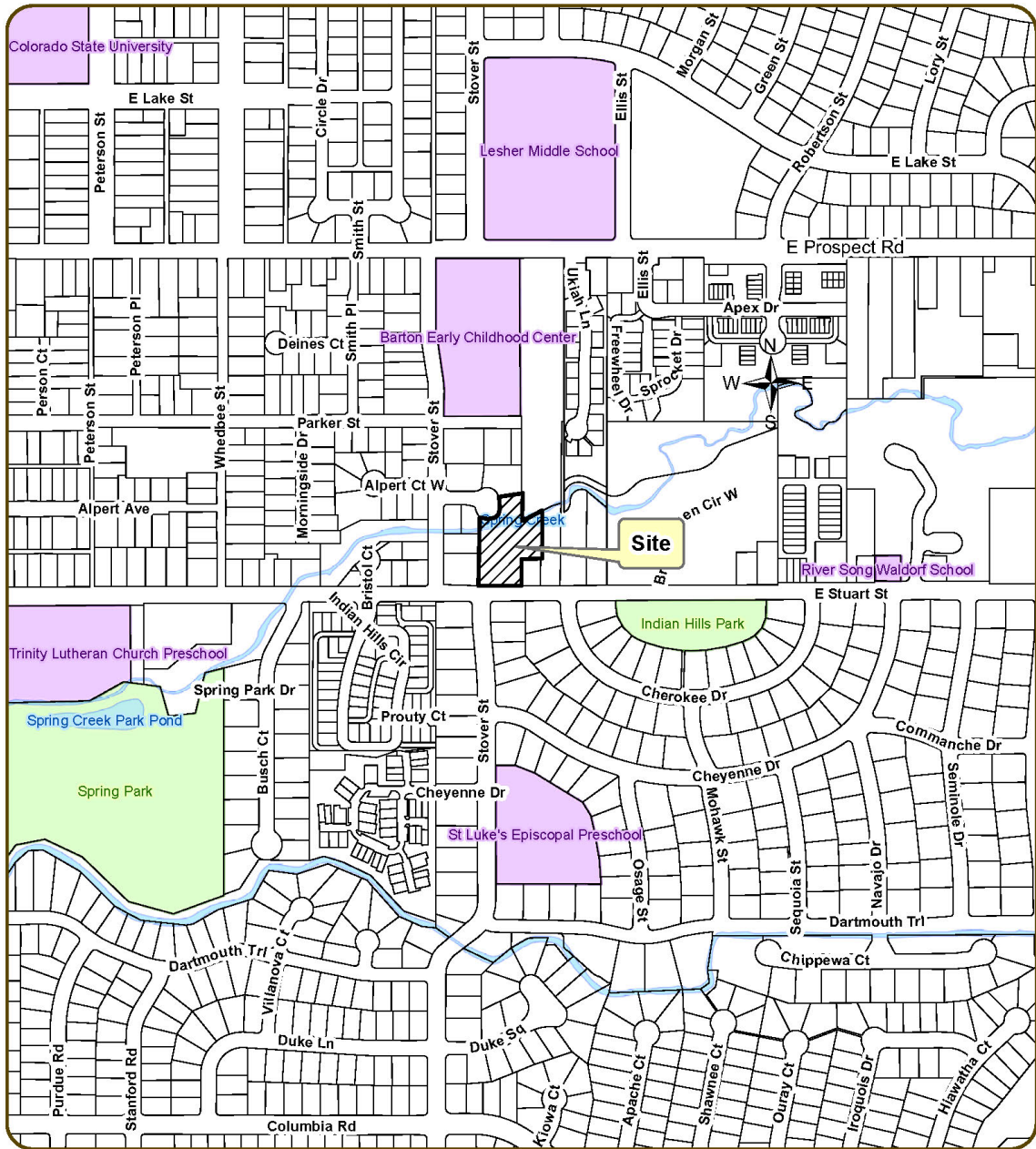

### PROPOSAL DESCRIPTION

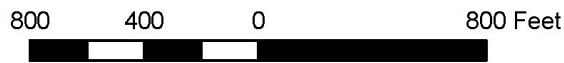
- The proposal is to consider a number of additional uses under the City's Addition of Permitted Use (APU) approval process under Section 1.3.4 of the City Land Use Code.
