Spark Multifamily Development, CDR200040


140 E. Oak Street – west of Remington Street and north of East Oak Street Sign #542 (Please see project location map on the back of this letter)

#### PROPOSAL DESCRIPTION

- This is a proposal for a 6-story mixed-use building with ground floor office/commercial spaces, second-floor parking, and affordable housing on floors 3-6.
- 78 dwelling units and 54 off-street parking spaces are proposed for the project. Access is proposed from Remington Street directly to the east.
- The site is approximately .5 acres within the Downtown (D) Zone District: Historic Core Subdistrict.
- The applicants are requesting a modification to allow a 6-story, 71foot building. The permitted height in this part of the Downtown Zone is 4 stories or 56 feet.
- This proposal will be subject to a review and public hearing by the Planning & Zoning Board (P&Z); residents who receive this letter will also receive a letter for the hearing.
