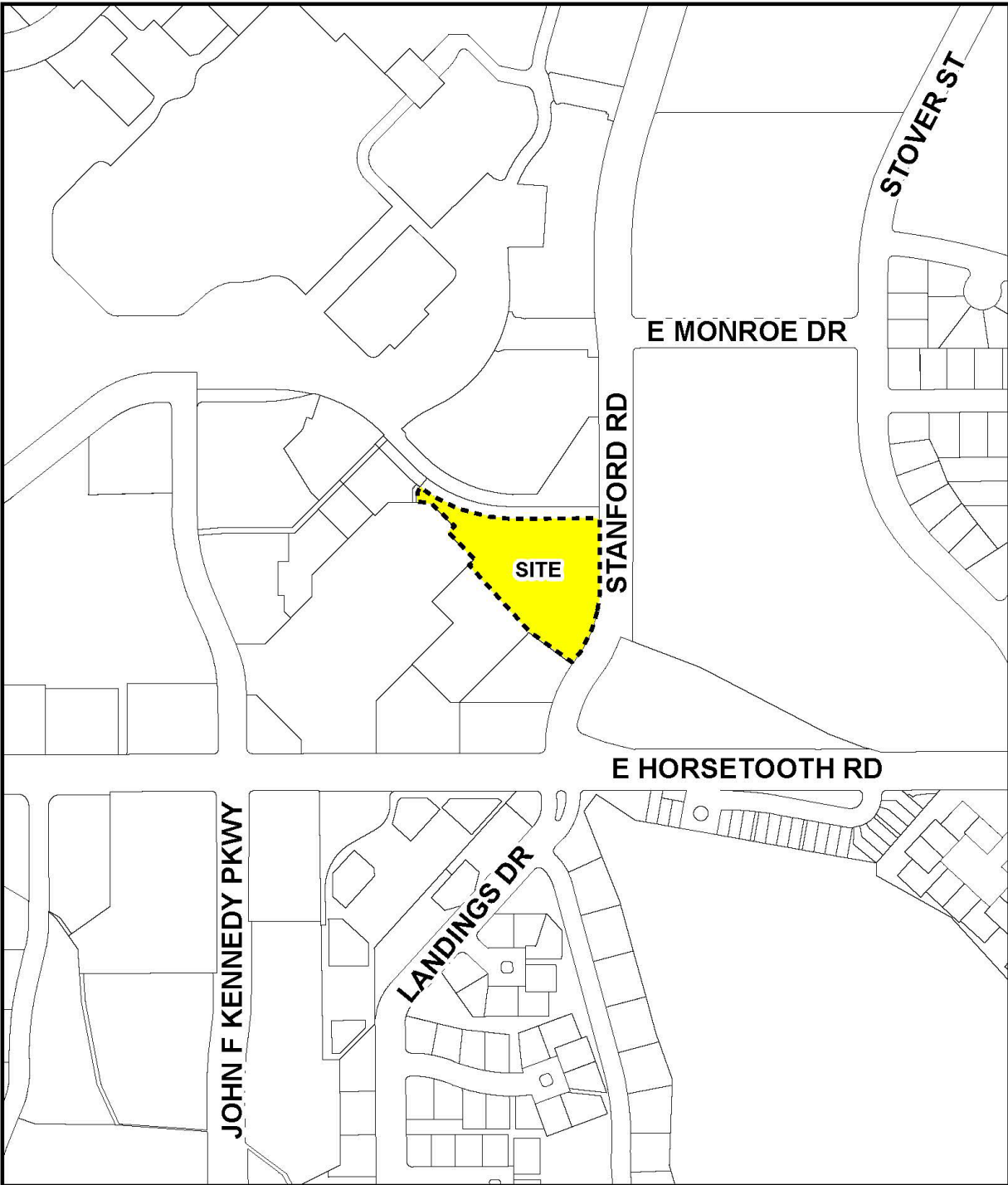
### PROPOSAL DESCRIPTION
