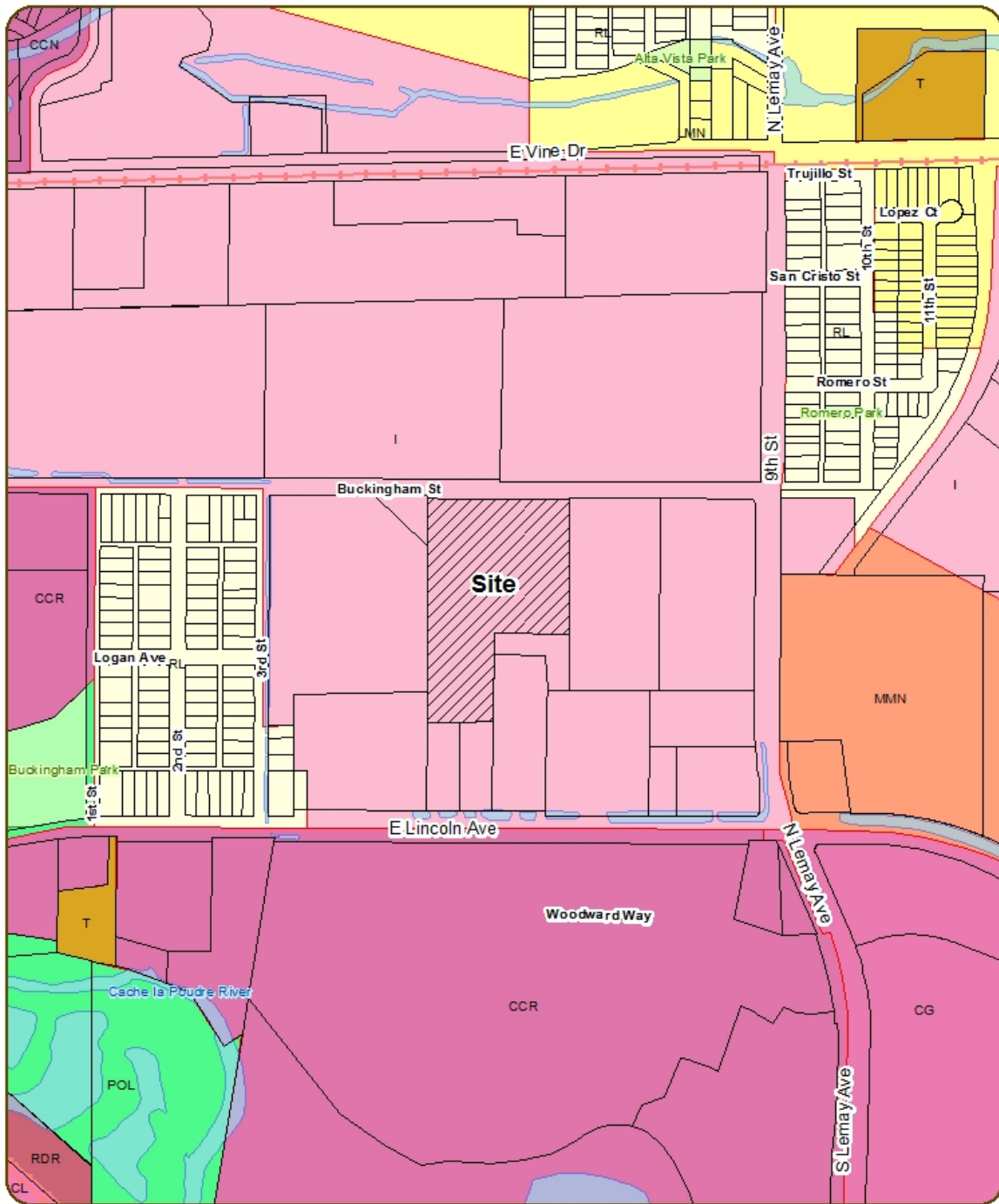
- 68' tall wireless telecommunications facility
