## PUBLIC NOTICE TWO-WEEK OPEN COMMENT PERIOD

January 28, 2019

Dear Property Owner or Resident:

The City of Fort Collins has received a request for installation of wireless telecommunication equipment in the 23 Church building at 1621 W. Harmony Road (see map on reverse). The request is formally referred to as **FTC Westbury**, **BDR180028**.

The project would replace the existing lighthouse-style feature on the roof of the 23 Church building with a new one that is five feet taller, with the same design; and install wireless telecommunication equipment concealed within.

This cell equipment installation is being processed per the City's Land Use Code, with the request to be considered administratively by the Development Review Manager. The code requires this mailed notification and a two-week open comment period during which comments can be provided to the Planning Services Department. This open comment period will be:



At the close of the comment period, the Development Review Manager must issue a written decision to approve, approve with conditions or deny the replat application based on compliance with applicable standards.
