Dear Property Owner or Resident:

On Monday, November 7, 2016, at 5:30 P.M., in Conference Room A, 281 N. College Avenue, Fort Collins, CO., the City of Fort Collins Hearing Officer will hold an Administrative Hearing to consider a development proposal. The project is referred to as **GRIT Athletics Facility**, **#PDP160024**.

As proposed, the project consists of constructing a one-story, 7,545 square foot building on a vacant lot located at 846 S.E. Frontage Road. The parcel is also identified as Lot 13 of the Amended Plat of Lots 13 and 14, Interchange Business Park.

The facility will be used as a non-profit wrestling facility with a progressive approach to the training of wrestling techniques. (GRIT: Grace Righteousness, Intensity and Toughness). Of the total building, approximately 4,784 square feet will be devoted to limited indoor recreation, 1,694 square feet will be used as office space, and 1,067 square feet will be for equipment storage. The site will be served by 20 parking spaces. The site is located in the General Commercial (CG) zone district.


