NOTICE OF PUBLIC HEARING

Dear Property Owner or Resident:

On Wednesday, August 30, 2017, at 5:30 p.m., in Conference Room A at 281 North College Avenue, the City of Fort Collins Administrative Hearing Officer will conduct a public hearing to consider a development proposal near your property. The project is referred to as **Harmony Commons Medical Office Building, Lot One #PDP 170023.**

This is a request to develop a 1.6 acre lot within the Harmony Commons commercial center. As proposed, the project consists of constructing a two-story, 25,000 square foot building located along Harmony Road between Technology Parkway and Lady Moon Drive. The site is zoned H-C, Harmony Corridor. The proposed use is for a medical office building. The site is a portion of Tract S (24.71 acres) of the Harmony Technology Park Overall Development Plan, Seventh Amendment, and represents phase five of a seven-lot commercial center.
