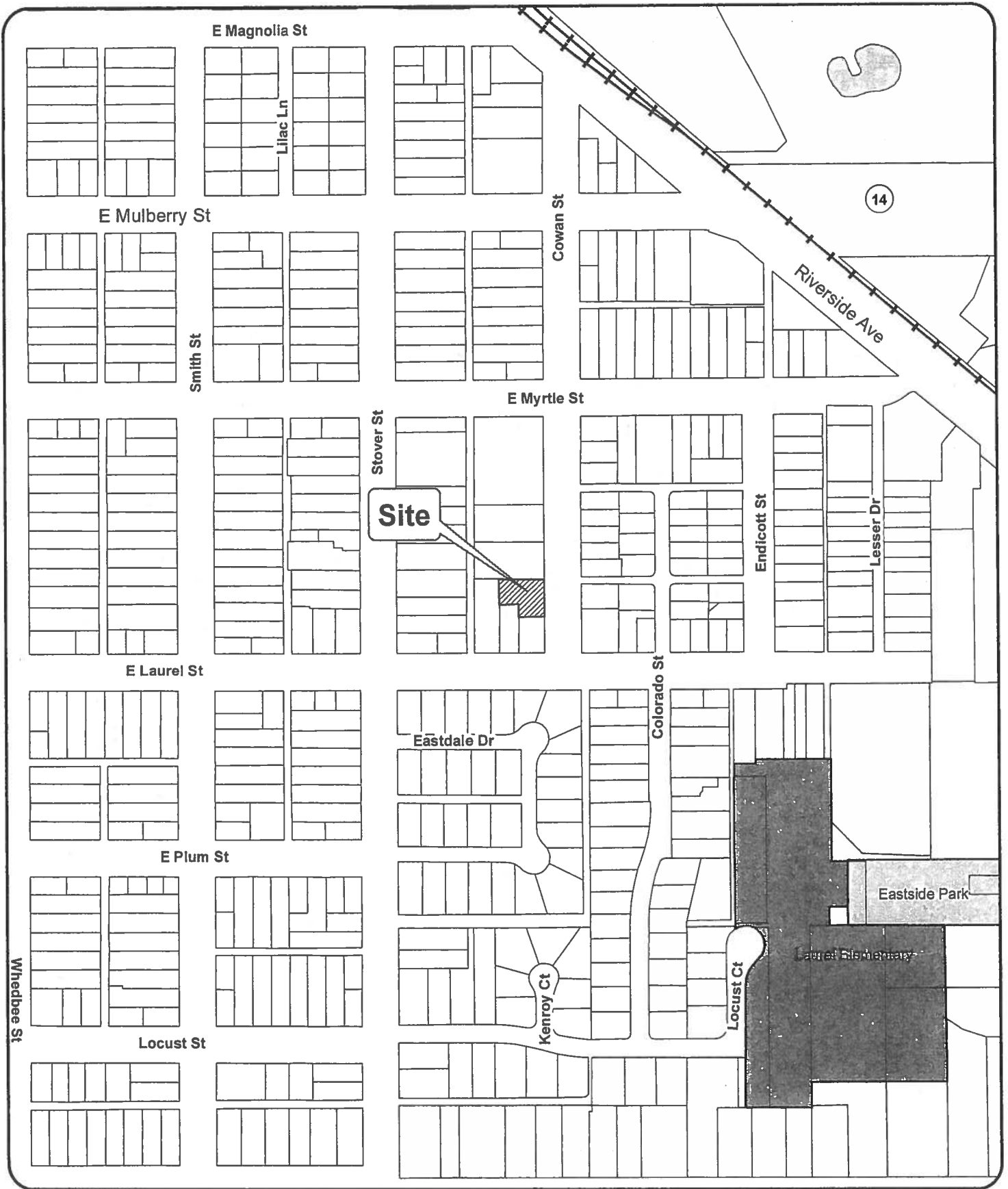
- Remove the existing structures
